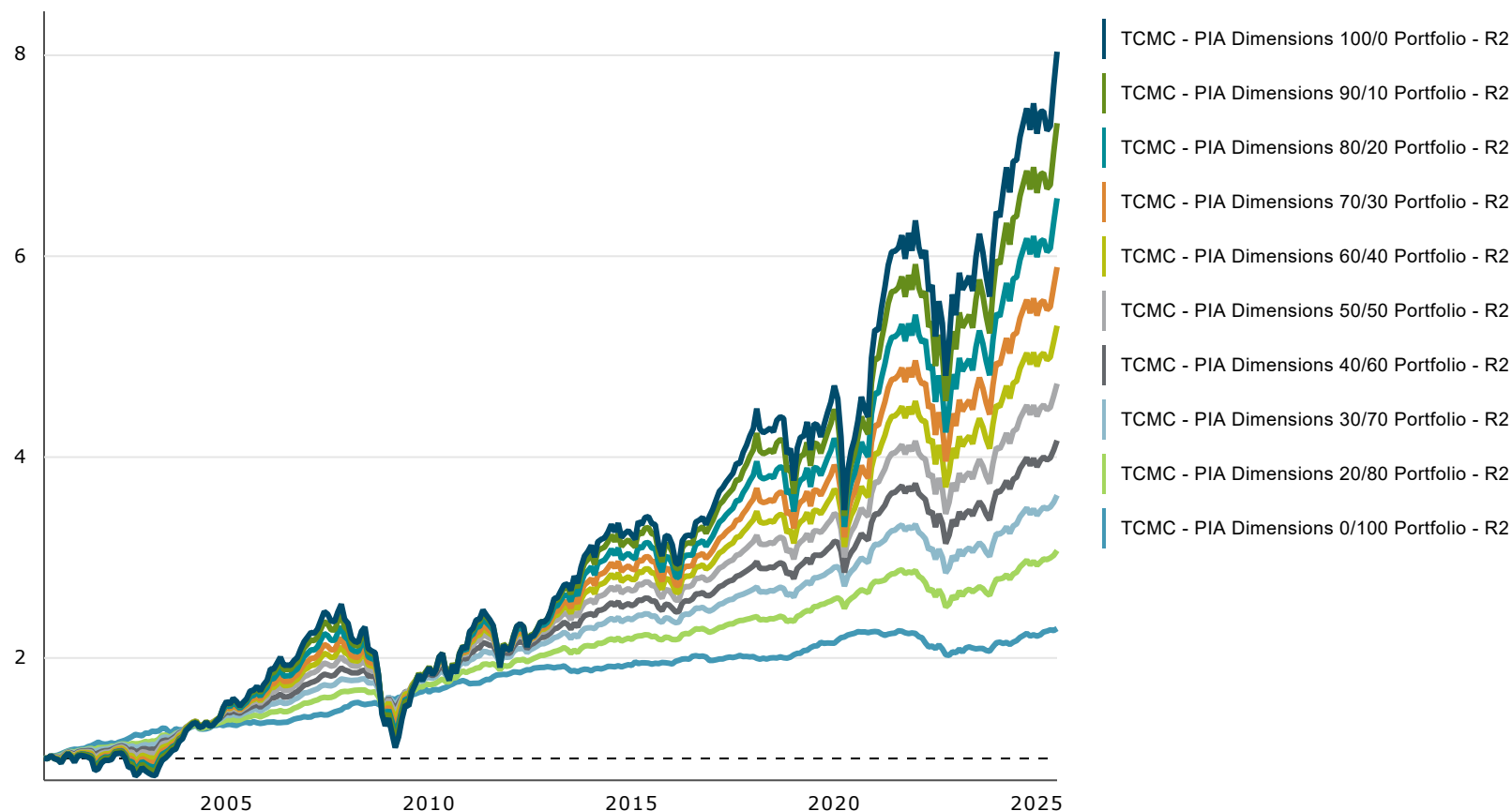

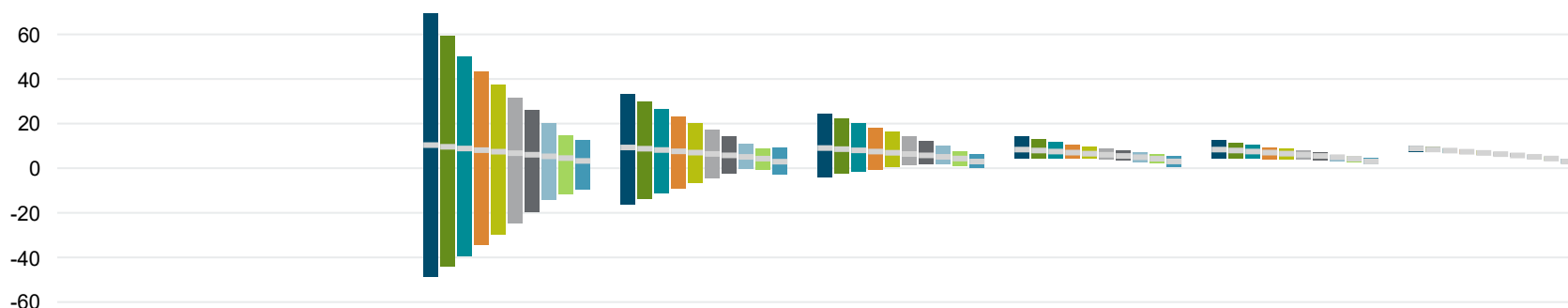

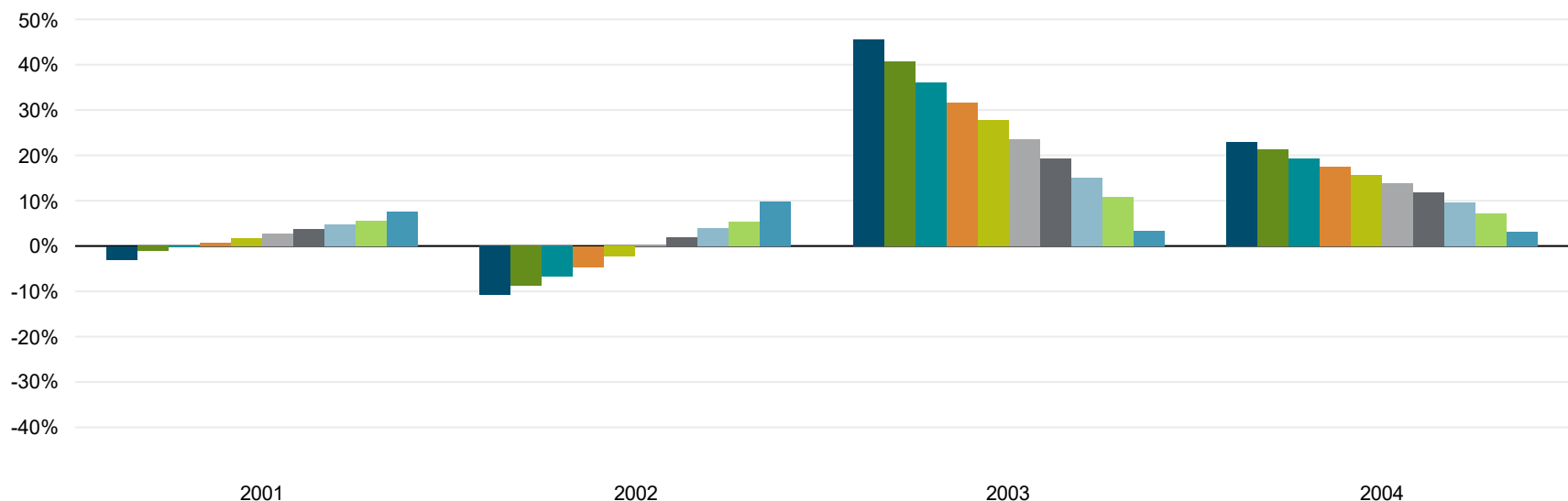

Calendar Year: 2001 - 2024



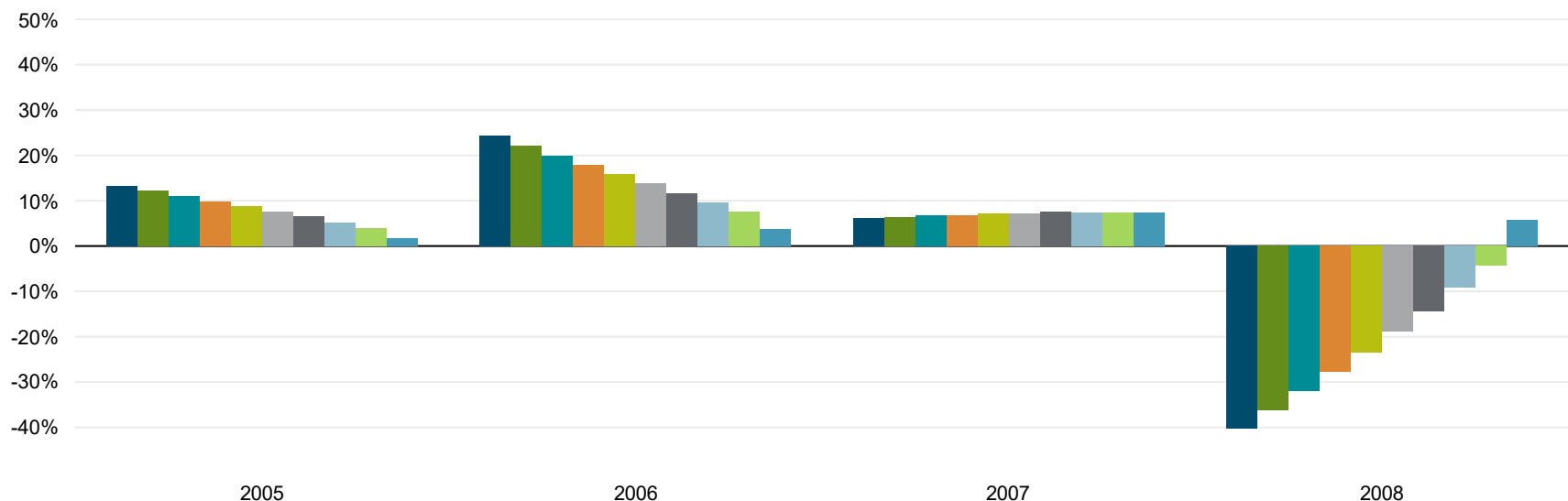

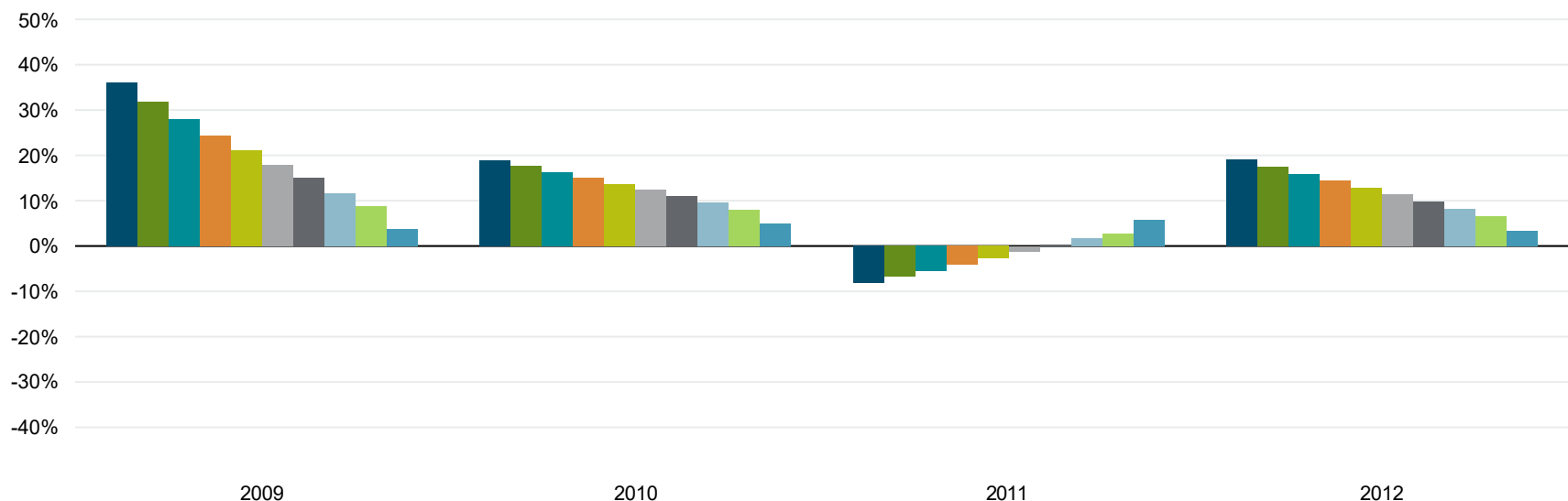

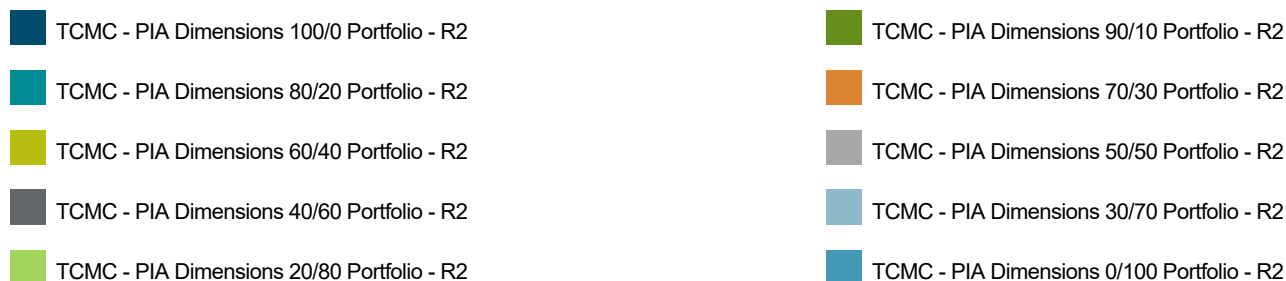

Calendar Year: 2001 - 2024



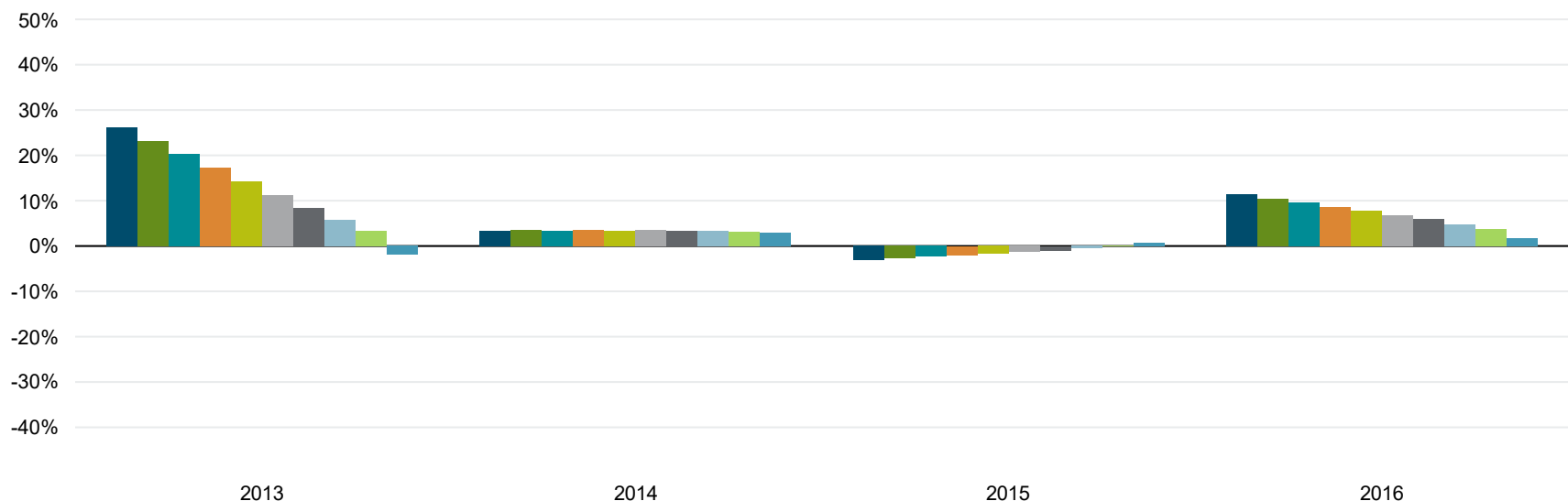

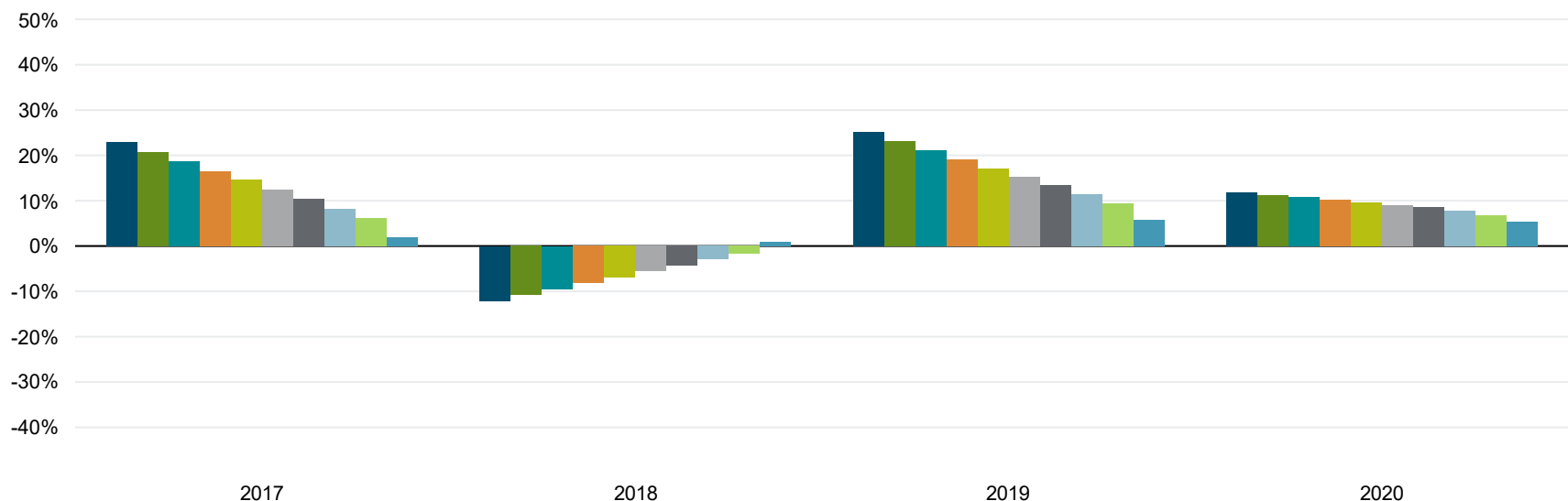

Calendar Year: 2001 - 2024

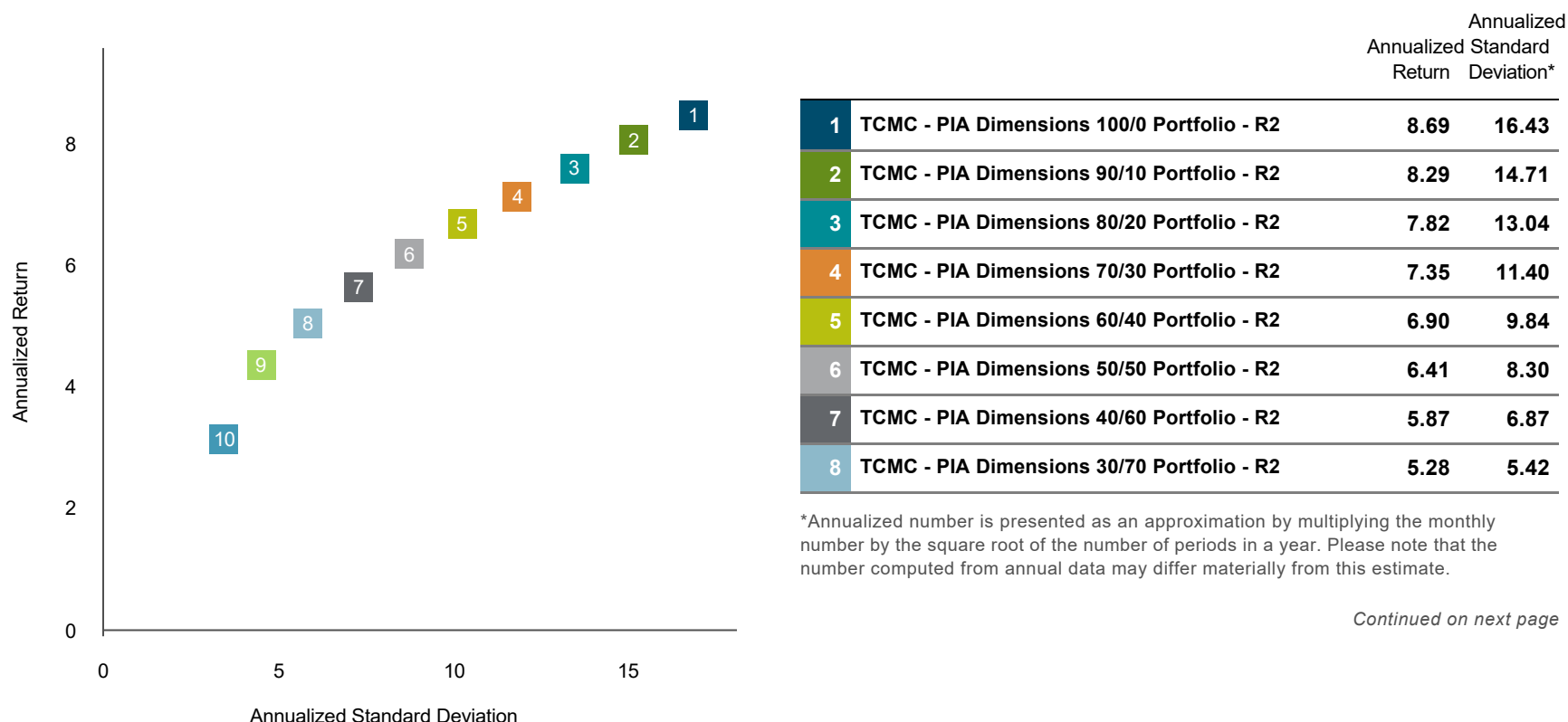

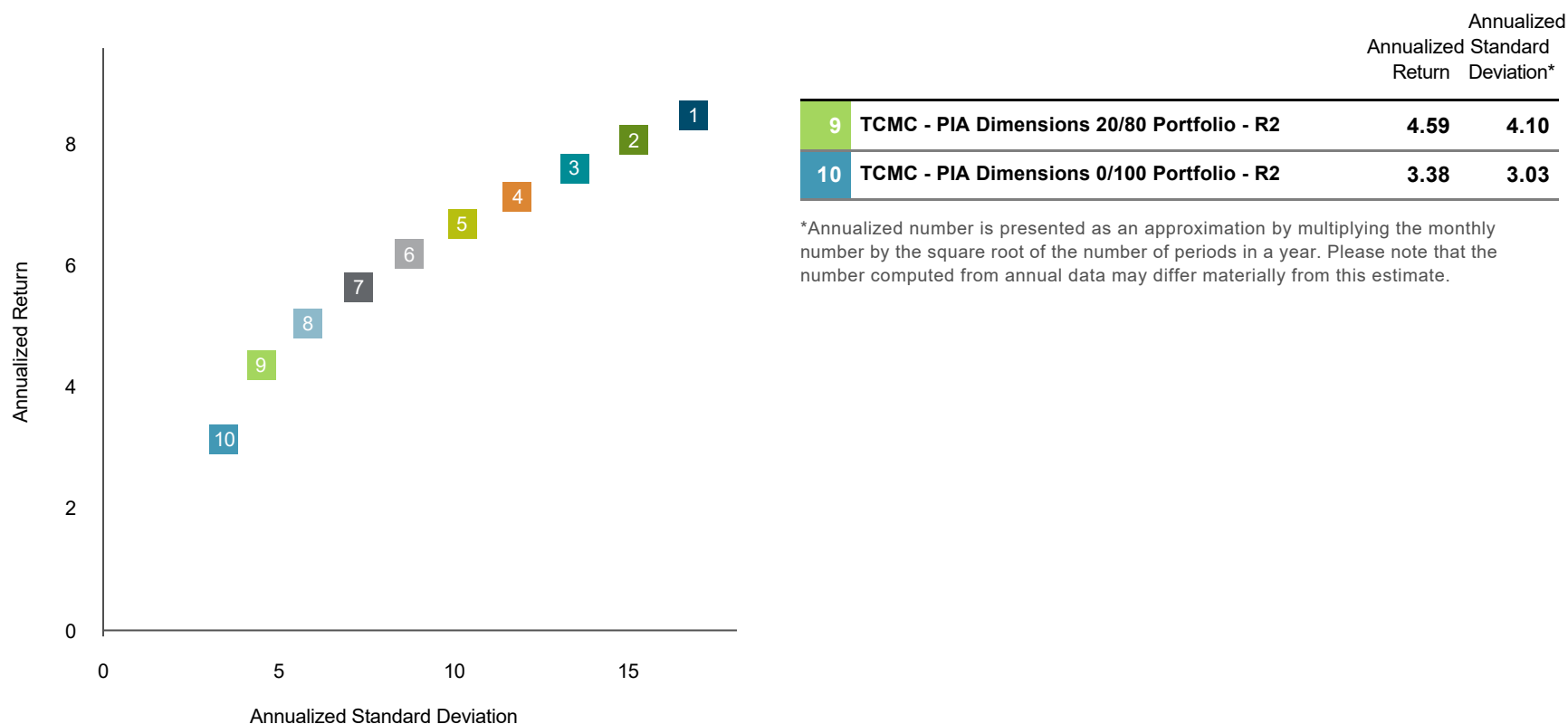
