# INVESTMENT OBJECTIVE


The investment objective of the Dimensional 2030 Target Date Retirement Income Fund is to provide total return consistent with the Portfolio's current asset allocation. Total return is composed of income and capital appreciation.

#### PRINCIPAL RISKS


